1. How to complete the form

Section 1,2,4 and 5 of this form must be completed by all applicants for new passports.

2. Authentication of application

The application must be authenticated and sponsored in section 5 by a citizen of Uganda of some standing.

3. Photographs

The copies of recent photographs of the applicant must be included with application.

These photographs must be taken full face without a hat, veil and must not be mounted.

The size of photographs must not be more than 3.5cm (1.5 inches) by 4.5cm (1.75 inches).

The photographs must be printed on normal thin photographic paper and must not be glazed on the reverse side.

The recomender is also required to endorse the reverse side of the one of the photographs with the words.

"I certify that this is a true likeness of the applicant Mr./Mrs./Miss.....
and his or her Signature."
